Report of independent auditors to the shareholders of ČESKÝ TELECOM, a.s.

We have reviewed the accompanying report on relations between ČESKÝ TELECOM, a.s. (the "Company") and its controlling entities and between the Company and the other entities controlled by the same controlling entities (the "Report") for the year ended 31 December 2002 on pages 4 – 40 of appendix to the annual report. The completeness and accuracy of the Report is the responsibility of the Board of Directors of the Company. Our responsibility is to review the accuracy of information included in the Report.

We conducted our review in accordance with the auditing standards of the Chamber of Auditors of the Czech Republic related to reviews of reports on relations between related entities. These standards require that we plan and perform the review to obtain moderate assurance as to whether the Report is free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to the presented data, and thus provides less assurance than an audit. We have not performed an audit and, accordingly, we do not express an audit opinion.

Based on our review, nothing has come to our attention that causes us to believe that the accompanying Report has not been properly prepared, in all material respects, in accordance with the provision of Section 66a (9) of the Commercial Code.

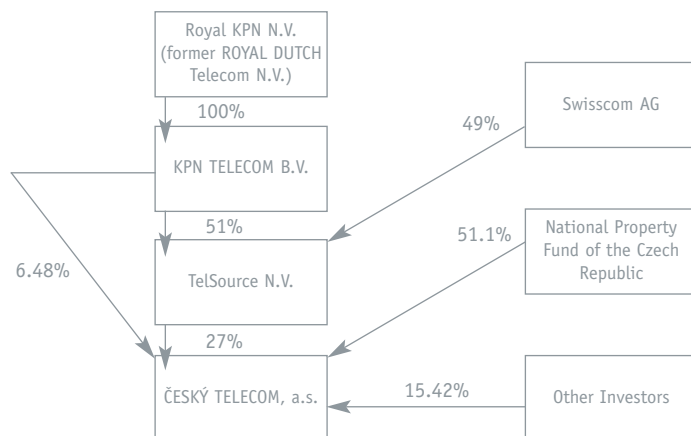

An additional share in the controlled entity's voting rights, according to the provision of Section 183d (4) b) of the Commercial Code, was 27.0% effective 8 September 1995.
Pursuant to the provision of Section 183d (4) c) of the Commercial Code, the additional share in the controlled entity's voting rights is 51.1% effective 8 September 1995.
The total share of the controlled entity's voting rights, according to provision of Section 183d of the Commercial Code, is 84.58%.

The total share in the controlled entity's voting rights, according to the provision of Section 183d of the Commercial Code, is 84.58%.

According to the provisions of Section 183d (4) c) of the Commercial Code, the additional share of Royal KPN N.V. in the controlled entity's voting rights is 51.1%, effective 8 September 1995.
The total share of the controlled entity's voting rights, according to the provision of Section 183d of the Commercial Code, is 84.58%.
Compared to 2001, the shareholders acting in concert have not announced any change to the controlled entity.

Relationships of the controlling entities

Royal KPN N.V. is the owner of 100% of the shares in KPN TELECOM B.V.
KPN TELECOM B.V. is the owner of 51% of the shares in TelSource N.V.
Swisscom AG is the owner of 49% of the shares in TelSource N.V.
KPN TELECOM B.V. and Swisscom AG act in concert and jointly control TelSource N.V.
The scheme of the controlling entities interconnection is as follows:



Other relationships of the controlling entities

KPN TELECOM B.V. owns 51% of TelSource Services B.V., who is the 100% owner of TelSource Services s.r.o.
Swisscom AG owns 49% of TelSource Services B.V..
KNP Czech Republic, s.r.o., in liquidation, is 100% owned by KPN TELECOM B.V.
TelSource N.V. and KPN are represented altogether by two members in the Board of Directors of the controlled entity and by two members in the Supervisory Board of the controlled entity. These controlling entities had three representatives in each of the noted organisations through 20 December 2002.

Part C Contracts and Agreements among the Holding entities for supplies during this accounting period which were concluded in the course of the accounting period of 2002 and Contracts and Agreements concluded earlier

Section I. Contracts and Agreements between the controlled entity and the controlling entities or the entities controlled by them

Other contracts

A contract was entered into between TelSource Services s.r.o. and the controlled entity regarding the provision of consultation services, dated 19 December 2001, including the Amendment No. 1 dated 30 September 2002. The validity of the contract was extended until 31 December 2003.

A contract regarding services concluded between KPN Czech Republic s.r.o., in liquidation, and the controlled entity as of 15 June 1999 was terminated by 31 December 2002 through the Amendment No. 3 dated 18 March 2002.

A contract between TelSource N. V. and the controlled entity was concluded regarding the construction of networks dated 3 June 1999.

A contract between TelSource N. V. and the controlled entity was concluded regarding the planning of the networks dated 23 July 1999.

Conclusion

In connection with the contracts and agreements concluded between the controlled entity and the controlling entities in 2002, based on which performance and counter-performance were provided, or in connection with the provision of performance and counter-performance in 2001 based on the contracts and agreements concluded before 1 January 2002, no detriment has been caused to the controlled entity. Performances and counter-performances arising from these contracts are stated in Annex to financial statement for 2002, in note No. 18.

Section II. Contracts and Agreements between the controlled entity and other interconnected entities controlled by the National Property Fund of the Czech Republic

Telecommunications Services

The controlled entity provided the following telecommunications services to some interconnected entities mentioned in Annex No. 1 and 2 to this Report, for which it accepted financial counter-performance, and a price was always determined in compliance with the valid price list, either as a regulated or a non-regulated price:

- public telephone service and other services supplementary to the telephone service as a part of the Universal Service, e.g. operator services, information on telephone numbers,
- other telecommunications value added services, e.g. Green Line, Memobox, Czech direct, Colour Lines, Audiotext,
- issue of telephone directories,
- euroISDN service,
- digital and analogue leased lines service,
- data services, e.g. ATM, Frame Relay, Packet Services,
- access to Internet network,
- Internet 2002 – ISP connection,
- lease of terminal equipment.

The information on contracting partners and the contracts concluded during the provision of the telecommunications services are considered by the controlled entity, in compliance with the Commercial Code and internal managing documents, to be a commercial secret. No detriment has been caused to the controlled entity by conclusion of these contracts or by the provision of telecommunications services for a consideration.

Media supplies

Contracts were concluded for power supplies and supplies of gas and water with the respective interconnected entities listed in Annex No. 3 in 2002 and before, according to the subject of their business. Financial counter-performance for the performances noted above was provided pursuant to the valid price lists by the controlled entity.

Lease of non-residential space

The controlled entity, as the lessee, and the interconnected entities stated in Annex No. 4, concluded contracts in 2002 and prior to 1 January 2002 regarding the lease of non-residential premises, for the purpose of the performance of the controlled entity's subject of business.

The controlled entity, as the lessor, and the interconnected entities stated in Annex No. 5, concluded contracts in 2002 and prior to 1 January 2002 regarding the lease of non-residential space, for the needs of these interconnected entities.

Other lease

The controlled entity, as the lessee, and the interconnected entities stated in Annex No. 6, concluded lease contracts in 2002 and prior to 1 January 2002, in a limited scope, regarding the lease of parking places or poles for the telecommunication lines.

The controlled entity, as the lessor, and the interconnected entities stated in Annex No. 7, concluded lease contracts in 2002 and prior to 1 January 2002, in a limited scope, regarding for cable duct holes, cable ducts and collectors.

Construction-assembly works

In 2002, the controlled entity and the interconnected entities stated in Annex No. 8 concluded contracts regarding the delivery of construction-assembly works performed by the controlled entity for financial counter-performance provided by the interconnected entities.

In 2002, the controlled entity and the interconnected entities stated in Annex No. 9 concluded contracts for the delivery of construction-assembly works performed by the interconnected entity for financial counter-performance provided by the controlled entity.

Sale of goods and services

In 2002, the controlled entity and the interconnected entities stated in Annex No. 10 concluded contracts for the sale of goods or services by the controlled entity for financial counter-performance provided by the interconnected entities.

In 2002, the controlled entity and the interconnected entities stated in Annex No. 11 concluded contracts for the sale of goods or services by the interconnected entity for financial counter-performance provided by the controlled entity, e.g. purchase of a network, repairs and spare parts of the motor vehicles, maintenance check-ups of distribution substations, training, accommodation, etc.

Contracts on transfer of the telecommunication equipment

In 2002, the controlled entity and the interconnected entities stated in the Annex No. 12 concluded contracts regarding the performance of transferring of the main telephone line or a ISDN2 line and the establishment of a branch exchange by the controlled entity for a financial counter-performance provided by the interconnected entities.

Equipment and Devices Overhaul

In 2002, the controlled entity and the interconnected entities stated in Annex No. 13 concluded contracts for equipment and facilities overhaul performed by the controlled entities for financial counter-performance provided by the interconnected entities.

Indemnification, Contractual penalties, Interests on Late Payments

In the last year, the controlled entity provided the interconnected entities, listed in the Annex No. 14, indemnifications resulting from the construction works, and reimbursed the contractual penalties or interests on late payments.

Project and geodetic services

In 2002, the controlled entity and the interconnected entities stated in Annex No. 15 concluded contracts for project and geodetic services performed by the interconnected entities for financial counter-performance provided by the controlled entity, e.g. location of a standard engineering network.

Repairs and maintenance of buildings and technical support of the buildings

In 2002, the controlled entity and the interconnected entities stated in Annex No. 16 concluded contracts for the repairs and maintenance of buildings performed by the interconnected entities for financial counter-performance provided by the controlled entity, e.g. connection to and disconnection from the power distribution and technical maintenance of buildings.

Printing and bill enveloping services

The performance was provided between the controlled entity and the interconnected entity Východočeská energetika, a.s. in the form of printing and accounts enveloping services. The financial counter-performance was based on the contract dated 15 September 1997.

The performance was provided between the controlled entity and the interconnected entity Východočeská plynárenská, a.s. in the form of printing and accounts enveloping services. The financial counter-performance was based on the contract dated 2 April 1998.

Contracts on Establishment of Right of User

In 2002 and since 1 July 2000, the controlled entity and some interconnected entities stated in Annexes No. 1 and 2 concluded contracts regarding the establishment of the right of user to real estates owned by the interconnected entities, for the purpose of the construction of overhead and underground lines of public telecommunications network, pursuant to Act No. 151/2000 Coll., on Telecommunications and on Change of Other Acts, as amended. Compensations for limitation by a right of user were stipulated in accordance with the price list based on the Statement of the Ministry of Finance in the Price Gazette No. 6/99.

Contract for Work

On 25 November 2002, the controlled entity and an interconnected entity, ESS s.r.o., concluded a work contract for the performance of an overhaul of the controlled entity's distributional transformer for a financial counter-performance of the controlled entity.

Conclusion

Additional detailed information regarding the concluded contracts are considered, and in compliance with the Commercial Code and internal managing documents, to be a commercial secret by the controlled entity. No detriment has been caused to the controlled entity in connection with the contracts and agreements concluded in 2002 among the controlled entity and other interconnected entities, based on which performance and counter-performance were provided, or in connection with the provision of performance and counter-performance in 2002, based on the contracts and agreements concluded prior to 1 January 2002.

Part D Legal actions among the Holding entities in the accounting period of 2002

In the accounting period 2002, no legal actions which would result in a detriment or benefit, advantage or disadvantage, were entered into between the controlled entity and the controlling or interconnected entities in the interest, or based on an initiation of the controlling or interconnected entities.

Part E Measures among the Holding entities in the accounting period of 2002

In the 2002 accounting period, no measure was taken or implemented by the controlled entity in the interest of, or based on an initiation of the controlling or interconnected entities, which would result in a detriment or benefit, advantage or disadvantage.

The controlled entity notes that pursuant to the governmental decree No. 1314 of 13 December 1999, the privatisation process was started, in the course of which due diligence was performed at the controlled entity, in 2002. The Government of the Czech Republic approved the sale of at least 51.1% of the controlled entity's shares through a selection procedure and entrusted the National Property Fund of the Czech Republic with its organization. Based on the agreement between the company TelSource N.V., its owners and National Property Fund of the Czech Republic, the total share that was to be sold should have reached 78.1% of the controlled entity's basic capital, depending on the resolution of TelSource N.V. to offer its shares in the selection procedure. The privatisation was terminated by the governmental resolution No. 1222 on 2 December 2002. The activities related to the due diligence were performed within the scope of usual activities of the controlled entity, by permanent employees within the scope of their usual working activities. Property used during the due diligence (premises, furniture of the premises, technology) and primarily, the outcomes of the due diligence, are continuously used in the usual course of the company. None of the above mentioned steps inflicted any detriment to the controlled entity.

The selection procedure was terminated by a governmental decree No. 1222 on 2 December 2002 without any final agreement having been reached regarding the selected applicant. Per the governmental decree dated 17 February 2003, it is expected that a new selection procedure shall take place from 2004 through 2005. Currently, it is not possible to assess any future prospective changes in the value of assets and debts of the controlled entity resulting from the privatisation process.

Part F Conclusion

- [a]** The Report has been prepared by the Board of Directors of the controlled entity, ČESKÝ TELECOM, a.s., and approved at the Board of Directors' meeting on 26 March 2003.
- [b]** The Report has been prepared based on the data and information obtained from the controlling and other interconnected entities, the Commercial Register, other available documentation and the results of the examination of the controlled entity's relations to the controlling and other interconnected entities. The Board of Directors of the controlled entity, ČESKÝ TELECOM, a.s. declares that it proceeded with due care when collecting the data and information.
- [c]** The controlled entity, ČESKÝ TELECOM, a.s., is obliged, in accordance with law, to prepare an annual report pursuant to Act No. 563/1991 Coll. on Bookkeeping, as amended, the Report will be attached to the Annual Report. The Shareholders will have the opportunity to obtain the Report in the same term and under the same conditions as the financial statements.
