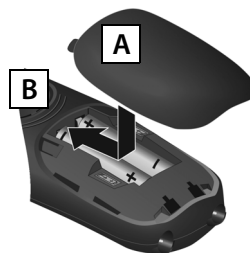
## 1 Vložení dodaných akumulátorů a zajištění krytu přihrádky na akumulátory



- > Nejprve vložte výstupek na krytce do vylišovaných otvorů na zadním krytu sluchátka **A**.
- > Poté na kryt zatlačte, aby zaklapl na místo **B**.

- > Při vkládání akumulátorů dbejte na správnou orientaci (naznačují ji symboly v přihrádce na akumulátory nebo na ní).
- > Používejte pouze doporučené dobíjecí akumulátory.

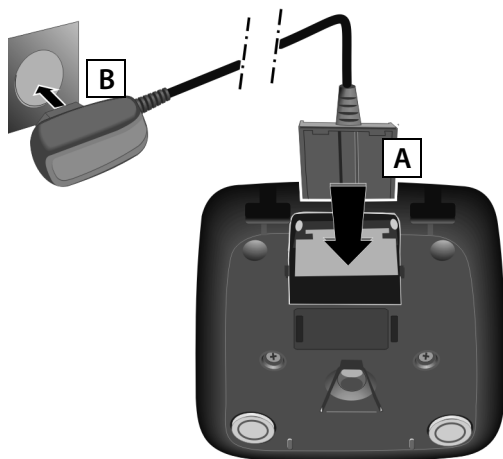
Po vložení akumulátorů se sluchátko automaticky zapne.



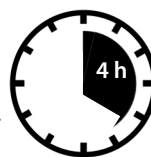
- > Displej je chráněn fólií. Před uvedením sluchátka do provozu ochrannou fólii odstraňte.


## 2 Připojení nabíječky a nabití akumulátorů

- > Dodržujte uvedený postup zapojení (A, B)!



- > Vložte sluchátko do nabíječky a počkejte, až se akumulátory plně nabijí (zhruba 4 hodiny).



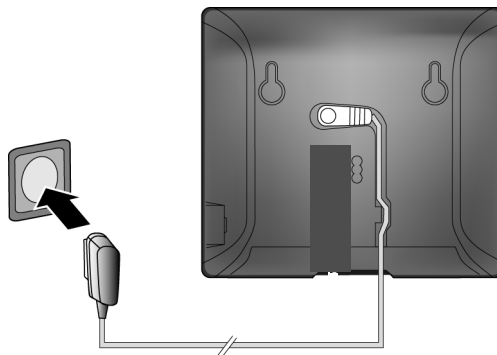
- > Zpět do nabíječky sluchátko znovu vložte až v okamžiku, kdy budou akumulátory zcela vybité.

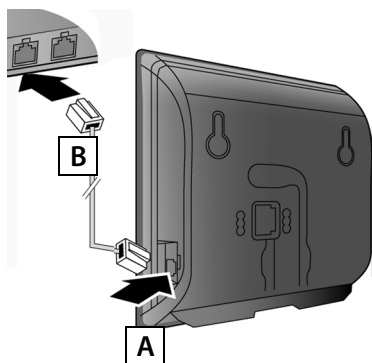
### 3 Připojení základny

Napájecí adaptér musí být za provozu **vždy zapojen** do elektrické zásuvky, protože telefon bez připojení k síti nefunguje.



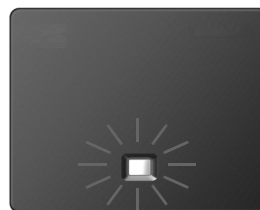
### 4 Připojení základny k routeru



- A** Zapojte konektor ethernetového kabelu do zdičky sítě LAN na boční straně základny.
- B** Druhý konektor ethernetového kabelu zapojte do zdičky sítě LAN na routeru.

Používejte pouze ethernetový kabel dodaný s telefonem.

Okamžitě po propojení telefonu a routeru kabelem a zapnutí routeru se rozsvítí tlačítko na přední straně základny (tlačítko pagingu).

#### Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users. This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below. When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

are the reason we use the ordinary General Public License for many libraries. However, the Lesser license provides advantages in certain special circumstances.

For example, on rare occasions, there may be a special need to encourage the widest possible use of a certain library, so that it becomes a de-facto standard. To achieve this, non-free programs must be allowed to use the library. A more frequent case is that a free library does the same job as widely used non-free libraries. In this case, there is little to gain by limiting the free library to free software only, so we use the Lesser General Public License.

In other cases, permission to use a particular library in non-free programs enables a greater number of people to use a large body of free software. For example, permission to use the GNU C Library in non-free programs enables many more people to use the whole GNU operating system, as well as its variant, the GNU/Linux operating system.
